

Peter Viggo Jakobsen

Peter Viggo Jakobsen (PhD) is Associate Professor at the Institute for Strategy and War Studies at the Royal Danish Defence College. He has acted as an advisor and consultant for several governments and international organisations.

Jakobsen is frequently used by the Danish and international media as a commentator on defence and security issues, has won awards for his teaching and public dissemination skills and has written extensively on many defence and security related issues.



Kevin Jon Heller

Kevin Jon Heller is Professor of International Law and Security at the University of Copenhagen's Centre for Military Studies and Distinguished Visiting Professor of Law at Universidad Torcuato Di Tella in Buenos Aires. He is an Academic Member of Doughty Street Chambers in London and currently serves as Special Advisor to the Prosecutor of the International Criminal Court on War Crimes.

Prof. Heller was one of Radovan Karadzic's formally-appointed legal associates at the ICTY; served as the plaintiffs' sole expert witness in *Salim v Mitchell*, a successful ATS case against the psychologists who designed the CIA's torture program; and acted as legal advisor to one of the defendants in the 9/11 trial at Guantanamo Bay.



Richard Lennane

Richard Lennane is Disarmament Adviser in the Legal Division of the International Committee of the Red Cross. He has long experience in multi-lateral disarmament and arms control, in government, the United Nations, and civil society.

Richard worked in the [United Nations Office for Disarmament Affairs](#) from 2001-2013, and was head of the [Biological Weapons Convention Implementation Support Unit](#) from its creation in 2007. From 2014-2016 he headed the innovative nuclear disarmament NGO 'Wildfire', and was Executive Director of the [Geneva Disarmament Platform](#) from 2016 to 2020. He served as a diplomat in the Australian Department of Foreign Affairs and Trade from 1992 to 2001, with postings to Egypt and Syria.



Iben Yde

Iben Yde advises public and private actors on the responsible development and use of artificial intelligence, particularly within the military and security sectors. She holds a PhD in international law and autonomous weapon systems and has over 15 years of experience researching the regulation of armed conflicts and new technologies.

Before joining Rethink Advisory, she led the Center for Operational International Law at the Royal Danish Defence College, which is primarily responsible for the legal training of Danish military personnel. She also has a background as a military legal advisor for the Danish Defence Command and has participated in three international missions. Iben has represented Denmark in forums such as the UN Group of Governmental Experts on Lethal Autonomous Weapon Systems (GGE LAWS) and NATO DARB.



Marc Schack

Marc Schack is an associate professor of international law and national security at the Faculty of Law (iCourts), University of Copenhagen, where Schack also coordinates the InterMil project. He earned his PhD in law from the University of Copenhagen in 2016 and has worked at institutions such as the Royal Danish Defence College, the Ministry of Justice, and the Centre for Military Studies.

Schack's research primarily focuses on the relationship between law and security, both from international and national perspectives. His work spans topics such as the international legal regulation of the use of force (*jus ad bellum*) and warfare (*jus in bello*/international humanitarian law), including prosecution in international courts, as well as Danish national security legislation, including defence and intelligence law.



Cecilie Felicia Stokholm Banke

Cecilie Felicia Stokholm Banke is a senior researcher at the Danish Institute for International Studies (DIIS). Her research focuses on Danish and European foreign and security policy, including the relationship between the EU and Turkey, the EU's foreign and security policy, remembrance after war and conflict. Banke has also worked as a lead investigator on DIIS's independent historical inquiry into Denmark's military and civilian engagement in Afghanistan from 2001 to 2021.

Her current research examines the ongoing changes in Europe and European cooperation within an increasingly multipolar world, where rule-based collaboration and multilateralism are under pressure due to growing great-power rivalries.
